What is Erasmus+?

- The Erasmus+ Program, which has been implemented in our country since 2004, is the general name of the umbrella program that includes support for different age groups and different target groups in the fields of education, youth, and sports.
 - Within the Erasmus+ Programme;
 - school education,
 - high education,
 - vocational training,
 - adult education,

- Support for the youth field continues, while grant support is provided for projects in the field of sports.

-Erasmus+ Student Learning Mobility

- This type of mobility involves part of student learning between institutions within the scope of the agreement at the university abroad consists of.


- The mobility period can be between 2 and 12 months, valid separately for each education level (associate/bachelor, master's, and doctorate).

- The duration of the months needs to be checked in IIA. Mobilities that are less than 2 months cannot be accepted.

- Students participating in mobility for one semester are required to take courses worth 30 ECTS. Full academic recognition is provided for successful credits in the program followed. Failed courses need to be repeated after the mobility.



Erasmus+ Student Learning Mobility Application Conditions

- Registered as a full-time student in a department/program at the associate, undergraduate, and graduate levels.
- To have continued education for at least one semester at the associate and undergraduate levels.
- Current GPA requirement for the application;
 - at least 2.20/4.00 at the associate and undergraduate level,
 - at the graduate level, it must be at least 2.50/4.00.

** There must be an Erasmus+ inter-institutional agreement specific to the department/program.



Erasmus+ Student Learning Mobility Application Conditions

- At the time of registration, graduate students who don't have a completed GPA in the program, can apply with their previous undergraduate or graduate GPA.
- Double major students can apply to the Erasmus+ exchange program for one of the two majors during the application period and join the movement.



Erasmus+ Student Learning Mobility Application Conditions

- Students of English and Turkish language preparatory programs and scientific preparation programs cannot apply to Erasmus+ exchange programs.
- Students who have frozen their registration cannot carry out student mobility during the period. However, an application for mobility can be made during the registration period.
- A student can perform a total of 12 months of mobility (study + internship) within the same education level.

Erasmus+ Student Learning Mobility Evaluation Criteria

Criterion	Score
Academic achievement level (according to the system equivalents of YÖK)	%50 (out of a total of 100 points)
Language Level	%50 (out of a total of 100 points)
Martyrs and veteran children	+15 points*
Students with disabilities (provided that it is documented)	+10 points**
Students for whom protection, care or accommodation decision has been taken within the scope of Social Services Law No. 2828 and Child Protection Law No. 5395 (provided that they are documented)	+10 points***



Erasmus+ Student Mobility for Studies Değerlendirme Ölçütleri

Criterion	Score
Earlier benefit (with or without grant)	-10 points
Participating in mobility in the country of citizenship	-10 points
Failure to participate in the mobility without giving a timely waiver notice despite being selected for the mobility	-10 points
Applying to two mobility types at the same time (reduction is applied to the student's preferred mobility type)	-10 points
For students selected for mobility: Not participating in meetings/trainings related to mobility without an excuse (applicable if the student applies for Erasmus again)	-5 points
Not taking the language exam without an excuse (applicable if the student applies for Erasmus again)	-5 points



Erasmus+ Student Mobility for Studies *Important Points When Choosing a University

- After the nomination process, students will make another application to the host institution.
- Being placed in an institution does not guarantee that you will receive a letter of acceptance, and it does not mean that the host institution will accept you.
- It is the responsibility of our students to apply to the institution and get a letter of acceptance.



Erasmus+ Student Learning Mobility *Important Points When Choosing a University

Therefore,

- You must check the host institutions;
 - Nomination deadline,
 - Application deadline,
 - Offered courses and their contents,
 - The required documents and qualifications (language certificate, etc.)



Erasmus+ Student Mobility for Studies Important Points When Choosing a University

- Institutions can make changes in the application conditions and deadlines. Therefore, it is the student's responsibility to follow the information about the application conditions of the host institution.
- Candidates should check the web page of the institution for application details.
- Candidates should contact department/program coordinators for the suitability of their preferences. The list of department/program coordinators is available on the web page.

Erasmus+ Student Mobility for Studies *Important Notes for Grant

- There are green travel opportunities provided to students who perform mobility to reduce carbon emissions and reduce the environmental footprint of mobility. Approval should be obtained from the National Agency for additional grant support.
- Additional Grant Support can be provided to disadvantaged students in addition to the grant they deserve.
- Approval should be obtained from the National Agency for additional grant support.



Erasmus+ Student Learning Mobility *Important Notes for Grant

- Grants are paid for a maximum of 5 months (150 days) to students who are eligible for mobility.
- Students can be able to waive financial support if they wish. However, they must be placed in an institution in the same placement period, on equal terms, by going through the application process.
- The grant calculation is based on the actual duration of the mobility.
- The student must be successful in at least 21 ECTS worth of courses taken in a semester at the host institution. Otherwise, a 20% deduction is applied to the final grants.



Erasmus+ Student Mobility for Studies Important Notes

- Expenses such as accommodation, transportation, and health insurance are the student's responsibility.
- Our students who are required to pay tuition fees must pay the fee to our University for the semester they participate in the Erasmus+ exchange program within the required period. However, they do not pay any tuition fees to the host institution within the Erasmus+.
- Host institution may request payment for the use of various materials such as insurance, residence permit, discounted transportation card, course materials, and laboratory products.



Erasmus+ Student Mobility for Studies *Important Notes

- In this process candidates should read the following documents carefully;
 - Announcements,
 - e-mails,
 - published guidelines,
 - The Erasmus+ exchange programs directive.
- The requested documents should be filled in electronically rather than in handwriting and submitted on time.
