INTRODUCTION

Hello,

The 3rd International Conference on Social and Educational Sciences was held in İstanbul/Türkiye, hosted by Fenerbahçe University, on 19-21 October 2023, with the participation of 147 people from 24 countries. 68 of the participants of the conference were from Türkiye and 79 were from different countries. Participants' countries are Bangladesh, Bulgaria, Cuba, Georgia, Germany, Greece, India, Indonesia, Kyrgyzstan, Kosovo, Lebanon, Malaysia, Maldives, Malta, Morocco, Nigeria, North Macedonia, Pakistan, Poland, Romania, Slovakia, Türkiye, Ukraine, and United Kingdom

A total of 96 valuable papers were presented at the conference. 24 abstracts and 17 full texts, total 41 papers from Türkiye; 11 abstracts and 40 full texts, total 51 papers were published from abroad. **The rate of full text foreign papers is 71%; The rate of full text local papers is 29%.**

First of all, I would like to thank all the participants for their scientific contributions to the conference and Fenerbahçe University Board of Trustees and Rectorate for their kind hosting. I would also like to thank the Dean of the Faculty of Economics, Administrative and Social Sciences, invaluable faculty members and volunteer students who made us feel at home.

I hope to be together in new scientific studies with the justified pride of successfully completing a large-scale organization with wide participation.

3. Uluslararası Sosyal Bilimler ve Eğitim Konferansı 24 ülkeden 147 kişinin katılımıyla 19-21 Ekim 2023'te Fenerbahçe Üniversitesi'nin ev sahipliğinde İstanbul/Türkiye'de gerçekleşmiştir. Konferansa katılanların 68'i Türkiye'den, 79'u farklı ülkelerden olmuştur. Katılımcıların ülkeleri Almanya, Bangladeş, Birleşik Krallık, Bulgaristan, Endonezya, Gürcistan, Hindistan, Kırgızistan, Kosova, Küba, Lübnan, Malezya, Maldivler, Malta, Morocco, Nigeria, North Macedonia, Pakistan, Polonya, Romanya, Slovakia, Türkiye, Ukrayna ve Yunanistan'dır.

Konferansta birbirinden değerli toplam 96 bildiri sunulmuştur. Türkiye'den 24 özet, 17 tam metin olmak üzere 41 bildiri; yurt dışından 11 özet, 40 tam metin olmak üzere 51 bildiri basılmıştır. **Tam metin yabancı bildirilerin oranı %71; tam metin yerli bildirilerin oranı %29'dur.**
